Sir,

With reference to above mentioned subject and letters under reference, Work Order No. 69/2016-17 dated 12.08.2017 and Work Order No. 25/2016-17 dated 25.07.2017 were issued in favor of you for installation of Grid connected Rooftop Solar Plant in the State. As per clause 3(b) of work order No. 69/2016-17 dated 12.08.2017, you have to submit the Performance Bank Guarantee @ 10% of the work order value & as per clause no. 4 of work order no. 25/2017-18 dated 05.07.2017, you have to submit Performance Bank Guarantee @ 10% of subsidy value and you have submitted the BG No. VIJB7205BG-18-19-35 dated 30.07.2018 of Rs. 5,40,000/- & BG No. VIJB7205BG-18-19-36 dated 09.08.2018 of Rs. 35,000/- issued from Vijaya Bank, Rabindra Sarani Branch, Kolkata (W.B) against the above mentioned work orders. During course of routine verification, a letter was sent to Vijaya Bank, Rabindra Sarani Branch, Kolkata. But in reply, Bank has confirmed vide its letter dated 30.10.2018 that the above Bank Guarantees submitted by you, have not been issued by its Branch and are fake in nature. The Bank Guarantees were also verified physically by representative of JREDA and the concerned Bank has again confirmed that the said BGs are fake and not issued by the branch i.e. Vijaya Bank, Kolkata.

JREDA, after finding that the Bank Guarantee are fake, a Show cause notice has been issued vide Letter No. 1369/2018 dated 05.09.2018 to you to explain as to why you have submitted the fake BGs. Reply has been received vide letter dated 14.09.2018 against above show cause letter. After having gone through your reply, it clearly transpires that the Performance Bank Guarantee submitted by you are found to be forged/fabricated upon verification with Vijaya Bank, Rabindra Sarani Branch, Kolkata (W.B.) and the same has been accepted by you. Although in your reply dated 14.09.2018, you have attempted to conceal these facts and mentioned the lacks of document procedural mistake in your reply. This shows your criminal attitude and forged behavior.

In view of the above facts and submission of forged & fabricated CPG BG No. VIJB7205BG-18-19-35 dated 30.07.2018 of Rs. 5,40,000/- & CPG BG No. VIJB7205BG-18-19-36 dated 09.08.2018 of Rs. 35,000/-, issued from Rabindra Sarani Branch, Kolkata (W.B.), JREDA in exercise the rights, power and authority vested in Director, JREDA under the terms and conditions of NIB, Work Order & Agreement, the aforesaid agreement no. 26/JREDA/ROOFTOP/17-18 dated 28.08.2017 & Agreement No. 57/JREDA/ROOFTOP/GOV/17-18 dated 05.10.2017 as well as Work Order No. 25/2016-17 dated 25.07.2017 & Work Order No. 69/2016-17 dated 12.08.2017 is hereby terminated with immediate effect.
