CIRCULAR

To all Energy Planner & Energy Audit Firms /Agencies

Sub: Empanelment of Energy Planner & Energy Audit Firms / Agencies

In order to continue its ongoing programme and also in the capacity of designated agency for State of Maharashtra under the Energy Conservation Act, 2001 & Energy Conservation Policy 2017 of the State, MEDA invites the applications from interested Audit Firms / Agencies for empanelment / registration for a limited period of **two years** on the following criteria:-

- i) Empanelment will be given to Energy Planner & Energy Auditing Firms / agencies and individual auditors it will be treated as **“Energy Planner & Energy Auditor”**
- ii) The energy auditing firms / agencies may be autonomous bodies, societies, industry associations, NGOs, Government departments, registered companies, partnership firms, Energy Service companies, academic institutions, individuals etc. working in India in the similar field.
- iii) Empanelment up to 2 years (from the date of registration) will be awarded to those successful energy planner & energy auditing firms / agencies which have been in the energy auditing business. Renewal may be carried out after expiry of registration period upon submission of requisite documents.
- iv) The Energy Auditing Firms / agencies should have to fulfill the following eligibility criteria for registration.

v) **The Energy Planner & Energy Auditing firms have to register their names by paying demand draft of Rs.10,000/- plus 18% GST as a one time registration fee (non-refundable) and demand draft of any nationalized bank of Rs.50,000/- (refundable) in favor of 'Maharashtra Energy Development Agency', payable at 'Pune'.**

vi) If required, MEDA may ask the applicant to make detailed presentation of their work in the field of Energy Audit before issuing empanelment certificate.

vii) It is the responsibility of the empanelled Energy Auditing firm to submit the quarterly report of Energy Audit conducted sector-wise as the state level Energy Efficiency indices needs to be filled & submitted to BEE, GoI.

If any of the empanelled Energy Auditing firm registered for Class A or Class B but not performing actively during the period of empanelment then his registration may be kept on hold giving a chance of six months at the time of renewal.

viii) MEDA at its discretion may visit any of the industry to verify the audit studies carried out by your firm during the period of empanelment.

ix) During empanelment period, if any sort of guidelines, rules & regulations laid by Central or

State government, then it will be applicable to empanelled consultants and are abide by the same.

- x) MEDA may withdraw the empanelment of an energy audit firm / agency if it is found on verification that the firm is indulging in unprofessional / unethical practices **& may forfeit the security amount of Rs. 50,000/-**.
- xi) Once registered, during the period of registration the Firms are eligible for Class up gradation from “Class B” to “Class A” provided they have to submit following documents :-

- The empanelment will continue only if all the condition is satisfied and if MEDA found the audit is in-correct or not followed the correct procedure as laid down by MEDA, then MEDA has reserve right to cancel the empanelment of respective firm / agency.
- 1) The temporary accreditation will be awarded for the period of 2 **years**.
 - 2) In case of any instance of unprofessional / unethical practices being adopted, the temporary empanelment along with **security amount of Rs. 50,000/-** would be automatically be revoked.
 - 3) The empanelled energy audit firm / agency will be required to submit to MEDA a copy of the report on energy audit, as and when conducted and completed by the firm / agency at the Consumer premises.
 - 4) Empanelment will be given to the auditing firm who has submitted the required documents to MEDA after announcement only.
 - 5) Director General, MEDA reserves all rights to accept or reject any or all applications without as signing any reasons and his decision will be final and binding to the party.

Subject: Submission of online fees for Empanelment of Energy Planner & Energy Audit Firms / Agencies

As per the guidelines for empanelment of Energy Auditing Firm dated on 12th October 2020, all the Energy Planner & Energy Auditing firms have to register their names by paying demand draft of Rs.10,000/- plus 18% GST as a onetime registration fee (non-refundable) and demand draft of any nationalized bank of Rs.50,000/- (refundable) in favour of 'Maharashtra Energy Development Agency', payable at 'Pune'.

But henceforth for new application, all the Energy Planner & Energy Auditing firms are requested to pay the one time registration fee (non-refundable)of Rs.10,000/- plus 18% GST and security amount of Rs.50,000/- (refundable) through Online mode only. The details of bank account are as follows:
