General Terms & Condition for SRRA data

I. General Guidelines

- 1. NIWE is responsible for operation and maintenance of SRRA stations as per relevant national/ international protocols. The data collected at the SRRA field stations are transmitted to the CRS at MEDA, Pune & NIWE, Chennai and data is subjected to quality checks and is preserved safely at multiple locations both raw as well as processed data.
- 2. MEDA to disseminate limited data through website. The following information is made available on the MEDA website:
 - i. A map showing all the SRRA stations
 - ii. Sample data files for a station (MEDA SRRA station).
- 3. Data provided to parties would be for their exclusive use only and under no circumstances, these data, in full, part or in any other form, is to be disclosed / distributed / copied / reproduced / transferred to other agencies either electronically or in physical form. Parties procuring data need to submit an undertaking to this effect. Disclosed / distributed / copied / reproduced / transferred to other agencies either electronically or in physical form. Parties procuring data need to submit an undertaking to this effect.
- 4. MEDA will be the sole and exclusive owner of the data, both raw and processed received from all SRRA stations to the CRS at MEDA, Pune & NIWE, Chennai. Access to the data from SRRA stations will be guided by the following principles: Access to the day to day data to each SRRA site owner for their use subject to the specific signing of Non-Disclosure Agreement (NDA). Publication of data in any form will not be allowed, unless otherwise specified with written permission obtained from the MEDA.
