## OFFICE ORDER

## Subject:- Blacklisting of M/s Sunfuel Technologies LLP, New Delhi.

Whereas, the work order for the installation of 325 kWp SPV Power Plant at 11 Nos. of different Police Station in Chandigarh vide CREST/03/2019/3791 dated 01.03.2019. The work order for the above said project was along with the 10 years of O&M and your firm submitted the Performance Bank Guarantee of amounting to Rs. 4,43,000/- of PBG bearing no. 210127IBGP00102 valid upto 05.04.2031.

Whereas, it has been found that your firm M/s Sunfuel Technologies LLP, New Delhi had stopped O&M for the above said SPV Power Plants.

Whereas, even after several reminders vide letter dated 13.07.2022, 23.02.2023, several emails and Show Cause Notice vide letter no. CREST/07/2022/1195 dated 13.07.2022, CREST/07/2023/1175 dated 11.07.2023, CREST/01/2024/3727-3728 dated 25.01.2024, CREST/02/2025/7027-7031 dated 18.02.2025, CREST/02/2025/7032-7035 dated 18.02.2025, CREST/02/2025/7036-7038 dated 18.02.2025, CREST/02/2025/7039-7040 dated 18.02.2025 your firm was directed to restart the O&M work. However, your firm had failed to respond to any of the Show Cause Notice and re-start the Operation and Maintenance for the above said SPV Power Plants.

Whereas, as per clause No.2.5 of DNIT at page no.47, " The supplier shall be responsible to carry out routine and preventive maintenance and replacement of each and every component / equipment of the power plant and he shall provide all labour, material, consumables etc. for routine and preventive maintenance at his own cost." However, your firm has failed to repair the SPV Power Plants to date.

Whereas, as per clause No.2.4 of DNIT at page no. 47, "Supplier shall depute on engineer of their company minimum Diploma in Engineering for the operation and maintenance of the plant who shall be fully responsible for the complete O&M and optimum operation of the plant. The name and contact nos. of this engineer shall be notified to the purchaser, for the purpose of contact, responsibility and correspondence with regard to all trouble shooting." However, no engineer has been assigned by your firm so far, even after several show cause notices.

Whereas, as per clause No.20 of DNIT at page no. 33, "Comprehensive insurance cover for men, machinery and all parts shall be arranged by the firm for entire period of contract and O&M and In case firm fails to provide such an insurance cover, after making any payment against the project the Department would get the material insured at the cost of recoverable from the firm". The insurance for the above said SPV Power Plants has remained unrenewed by your firm since January 2022. Whereas, as per clause No.2.4 of DNIT at page no.47, "In case of delay in repair & maintenance and non observance of purchasers O&M schedules, the purchaser shall have the right to impose any penalties including forfeiture of performance security".

Whereas show cause notices were issued as mentioned above. However, no reply has been received from your side in this office till date, which shows that you have intentionally stopped the O&M.

Therefore, in view of above the Bank Guarantee no. 210127IBGP00102 dated 09.02.2021 valid upto 05.04.2031 amounting to Rs.4,43,000/- is hereby forfeited and your firm i.e. M/s Sunfuel Technologies LLP, New Delhi and the Directors of your firm names (Sushil Kumar Singhal DIN No- 03034901, Aadhar Card 8503 3073 4769 and PAN no. AATPK2895G, Sumit Solanki DIN No- 03573370, Aadhar Card 6278 5617 4978 and PAN no. BDGPS4623B, Ashish Singhal DIN No- 07194974, Aadhar Card - 6005 6134 5024 and PAN no. DMNPS8278G and Kamal Solanki DIN No- 03573363) are debarred from all future tenders of CREST and also blacklisted from immediate effect for 2 years. Further CREST reserves rights to avail other legal remedies available to it as per the applicable laws.
