

PUBLIC NOTICE

TO WHOMSOEVER IT MAY CONCERN

Notice is hereby given to the public at large that, as a routine process, while addressing the queries of some organization; we have observed that some manufacturers submitted forged/Fake test reports claimed to be issued by "Hi Physix Laboratory India Pvt. Ltd."(Hi Physix) and the same was communicated to the concern nodal agency by us. Following a strict action, the nodal agency has banned some manufacturers for participation in any tender for next five years.

Consequently, one of the manufacturers registered an FIR in the name of **Mr. Sameer Kulkarni, founder/director of SOLCERT INDIA LLP for providing them a fake/forged test report.** FIR number being 0490 dated 15/07/2021 under section 420,465 and 467 of Indian Penal Code was registered in MIDC Police station, Jalgaon, Maharashtra.

It is clearly mentioned in the FIR that on behalf of SOLCERT INDIA LLP, Mr Sameer Kulkarni accepted the payments in personal account as well as the bank account of SOLCERT INDIA LLP and provided them Fake/Forged test reports on the letter head of Hi Physix Laboratory India Pvt Ltd.

On inquiry conducted by our company, **Mr. Sameer Kulkarni S/o Mr Shamrao Dattatraya Kulkarni R/o Flat No.6, Takshashila Apartment, Shalimar, Nashik, Maharashtra PIN 422001** was found to be engaged in fraud, misconduct and party to unethical practices. Due to the said reason, Hi Physix has also initiated appropriate legal action against Mr. Sameer Kulkarni and his company SOLCERT INDIA LLP and at present police enquiry/investigation is in progress against him, his organization, his business partners and other related persons who are having hand in gloves.

Mr. Sameer Kulkarni who happened to be our employee and cheated to us also was relieved from his duties/responsibilities on 30.04.2021 and from our company on 19.05.2021 and no longer represents Hi Physix.

We hereby caution, advise to beware of dealing with Mr. Sameer Kulkarni, his company SOLCERT INDIA LLP., his any other company/associate or his business partners.

Further, we hereby confirm that we "Hi Physix" don't have any association in any means with Mr. Sameer Kulkarni, his company SOLCERT INDIA LLP., his any other company/associate or business partners. Any person/company dealing in or intending to deal with these individuals/company will be doing so at his/her own risk, costs and consequences and Hi Physix Laboratory India Pvt. Ltd. will not be responsible in any manner whatsoever.
