

- 4. Quotation should be submitted in self address **sealed** envelope & written name of work on right top corner of envelop.

C. General Instructions:

- Work should be completed strictly under the supervision of MEDA Head Office/ respective MEDA Divisional office.
- 2. Work should be carried out & completed within 30 days from the date of issue of the work order.
- 3. MEDA will not be responsible for any loss occurred during execution of work.
- 4. For any disputes arising in this regard, decision of Director General, MEDA will be final.

- 5. If work is not completed within the specified period, then MEDA reserve the right to cancel the work order at any time and reserve to initiates necessary action against your firm for not completing the work within time.
